Heritage and Design Excellence Award Nomination

The 2019 nomination categories are:

1. **Conservation of a heritage place or object** – recognising excellence in conservation or restoration of a heritage place or object. Eligible projects include but are not limited to: those involving heritage buildings, historic collections, trees, parks and gardens, streetscapes, archaeological sites, cemeteries, precincts and structures, such as bandstands or statuary.

Eligible projects for this category are those which demonstrate the *adaptive reuse* of a disused or redundant heritage place or those that demonstrate how a project has sought to *conserve and retain* the significance of a place or object through restoration, reconstruction, conservation or maintenance.

The winning nominations will be outstanding examples of best practice approaches, which clearly demonstrate adherence to the Australia ICOMOS Burra Charter and other recognised local and state policy and guidelines regarding development and use of heritage places. To assist eligible projects pursuing nomination for the UNESCO Asia Pacific Awards, judging criteria will align with the UNESCO criteria of Understanding of Place, Technical Achievement and Social Impact.

2. **New designs in a heritage context** – recognises outstanding design that is sympathetically integrated into a heritage place, heritage precinct or heritage landscape. Eligible works include but are not limited to: new buildings or structures, new gardens and/or parks, new public spaces and extensions to existing buildings.

This category applies to new works within the Heritage Overlay. Works must demonstrate excellence in design, be sympathetic to and enrich the heritage context in which they are located.

To assist eligible projects pursuing nomination for the UNESCO Asia-Pacific Awards, judging criteria will align with the UNESCO criteria, including design concept, appropriateness, community impact and project influence.

- 3. **Excellence in heritage skills** recognising tradespeople, professionals, researchers, conservators, artisans, organisations and community groups who apply specialist knowledge or traditional methods/craftsmanship in their work, demonstrating best heritage conservation practice and/or research to a very high standard.
- **4. Communicating, promoting and celebrating heritage** recognising best practice and innovative work that contributes to sharing and supporting all the stories that make Ballarat distinctive. Eligible projects include but are not limited to: storytelling through events, exhibitions, published materials, performances and technology, such as 3D, websites, films, augmented and virtual reality, apps, blogs, etc.
- 5. **Mayoral Award for emerging heritage and design practitioners** recognising an outstanding individual or group of emerging practitioners with less than 7 years' experience in any aspect of the cultural heritage and design fields. This includes but is not limited to: tertiary students, designers, architects, archaeologists, historians, curators, archivists, planners, conservators, tradespeople and researchers.

Nominees will be evaluated based on their community impact and demonstrable contribution to the interpretation, understanding or conservation of cultural heritage and historic contexts. This may be in relation to a specific project and/or a body of work.
